Definition: 1) Black People in terms of the DTI Codes of Good Practice is a generic term which means African, Coloured and Indian South African citizens. 2) The DTI amended Codes of Good Practice Government Gazette 36928 states that an entity with an annual turnover less equal or less than Fifty Million(R50 000 000.00) qualifies as a Qualifying Small Enterprise(QSE), An QSE is deemed to have a BBBEE Status Level Four which will be elevated based on the percentage of Black Ownership of the entity, i.e. Black Ownership more than 50% but less than 100% will be elevated to BBBEE Status Level Two and Black Ownership of 100% will be elevated to BBBEE Status Level One.

3) As per the DTI Amended Codes of Good Practice, The authorized Individual of the entity is only required to obtain a BBBEE Sworn-Affidavit to confirm an QSE entity's Turnover and BBBEE Status.
